The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

- 1. Schedule B (In-Kind Contributions) of the July 25, 2022 report lists three monetary contributions, totaling \$750 from political action committees. These monetary contributions should be listed on Schedule A (Contributions and Other Receipts) and removed from Schedule B. Contributions deposited into the campaign bank account are to be reported on Schedule A, not Schedule B. An amended Schedule A (Contributions and Other Receipts) must be filed listing the contributions.
- 2. Schedule D (Other Transactions) of the July 25, 2022 report lists a \$120 reimbursement to Angela Martinez on 7-25-22 for the filing fee. If the filing fee was reimbursed to the candidate on 7-25-22, it should be removed from Schedule A (Contributions and Other Receipts) as a loan from the candidate and also from Schedule D since it was reimbursed. Also, Schedule C (Expenditures and Other Disbursements) of the report should be amended to reflect the date the candidate was reimbursed for the filing fee and the name and address should be the candidate's, not the Kansas Secretary of State. However, if the loan has not been repaid, it should remain on Schedule D and also reported on Schedule B (In-Kind Contributions) as an in-kind contribution from the candidate. Only contributions deposited in the campaign bank account and expenditures made from that account are to be reported on Schedules A and C. An amended report must be filed correcting these errors.
