1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Turk campaign reported receiving a \$1000 contribution on 6-22-22 from Rob Patterson. This contribution was received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. **The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the October 31, 2022 Receipts and Expenditures Report.**

2. Schedule D (Other Transactions) of the July 25, 2022 Receipts and Expenditures Report shows a \$5,000 loan from Adam Turk. All loans should **also** be listed on Schedule A (Contributions and Other Receipts). An amended report must be filed which includes this loan on Schedule A and the corresponding entries on Line 2 of the cover summary page.
3. The July 25, 2022 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 25, 2022 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
