- 2. Schedule C lists a \$6,218.64 payment to Record News for the purpose of "printing political flyers" on 10/28/21. If these flyers were in support of any candidates, the report must be amended to list which candidates and how much of the expense was allotted to each candidate.

If the required information will not fit in the "Purpose of Expenditure" box on Schedule C, or if you prefer, you may submit a supplemental list to serve as the amendment, provided that the list contains all of the required information. If this expense was not in support of any candidates, please provide further detail in a letter to the Commission.
