- 1. Schedule A (Contributions and Other Receipts) of the January 10, 2022 Receipts & Expenditures report must be amended to include the following information:
  - a. The occupation of individuals giving more than \$150 to the committee during the reporting period
  - b. A column to specify the method of each contribution (cash, check, loan or e-funds/other)
- 2. Schedule C (Expenditures and Other Disbursements) of the January 10, 2022 Receipts & Expenditures report must be amended to include the following information:
  - a. The address of every individual or vendor to whom an expenditure over \$50 (in aggregate across the reporting period) was made
- 3. Pursuant to Article 19-29-3(a)(1), the Kansas Physical Therapy PAC must file all future reports either using forms prescribed by the Commission OR by e-filing on the Secretary of State's website. Should the latter option be chosen, the e-filing system allows users to convert an uploaded spreadsheet into the appropriate format.
