The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. According to the reports filed with the Secretary of State, Broderick Henderson reports making a \$300.00 contribution on 10/31/2008 to the Kansas Democratic Party. This contribution was not reported by your committee. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) of the January 10, 2009 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the committee did not receive this contribution please note this fact in a letter to the Commission.

2. Schedule A of the January 10, 2009 Receipts and Expenditures report receiving a \$3,000.00 contribution from Tony Brown for Kansas on 10/5/2008. However, Tony Brown does not report making the \$3,000.00 contribution to the Kansas Democratic Party. An amended January 10, 2009 report must be filed to remove the contribution from Schedule A or to list the correct donor of the \$3,000.00 contribution.

3. According to the reports filed with the Secretary of State, Rebecca Escalante reports receiving a \$500.00 contributions from the Kansas Democratic Party on 11/3/2008. The \$500.00 contribution was not reported on Schedule C as being given by your committee. If this contribution was given, it must be reported on Schedule C (Total Expenditures and Other Disbursements) of the January 10, 2009 report. If the committee did not give this contribution, please note that fact in a letter to the Commission.

4. Schedule A of the January 10, 2009 Receipts and Expenditures Report lists receiving a loan from Central Nation Bank in the amount of \$60,000.00 on 10/24/2008 and \$15,000.00 on 12/03/2008. An amended Schedule D (Other Transactions) must be filed to show the name and address, date, the nature of the loan, and the balance of the loan at the close of the period.
