The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. K.S.A. 25-4153 (d) states, "The aggregate amount contributed to a party committee by a political committee shall not exceed \$5,000.00 in any calendar year." The Senate Democrats Committee reports receiving a \$10,000.00 contribution on 10/27/2008 from Kansans for Lifesaving Cures PAC.

2. K.S.A. 25-4153 (d) states, "The aggregate amount contributed to a party committee by a person shall not exceed \$5,000.00 in any calendar year." The Senate Democrats Committee reports receiving a \$1,000.00 contribution on 10/08/2008 and a \$5,000.00 contribution on 10/28/2008 from Hensley for Senate.

Pursuant to K.S.A. 25-4153, the Senate Democratic Committee accepted contributions in excess of the legal limit. We would suggest that these excess contributions be refunded immediately. Copies of these refund checks must be submitted to the Commission within 30 days. The return of these contributions should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2010 Receipts and Expenditures Report.

3. K.S.A. 25-4148 (b)(7) requires that when an expenditure is made by payment to an advertising agency, public relations firm or political consultants for disbursement to vendors, the report of such expenditure shall show in detail the name of each such vendor and the amount and date of the payment to each.

An attachment to Schedule C of the January 10, 2009 Receipts and Expenditures Report lists three expenditures made to Frye Allen totaling \$41,000.00 for television production and advertising. Please submit the required supplemental information as an amendment to Schedule C of the January 10, 2009 report. A copy of the invoices from Frye Allen will be acceptable
