
File the amended report within thirty (30) days with:

As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. The beginning balance of \$4,462.44 listed on the January 10, 2009 report is not the same as the ending balance of \$8,152.28 listed on the October 27, 2008 report. This difference of \$3,689.84 must be explained in an amended report.
2. According to the reports filed with the Secretary of State, Dennis McKinney reports making a \$1,000.00 contribution on 11/1/2008 to the Kansans for a Democratic House. This contribution was not reported by your committee. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) of the January 10, 2009 report. If the committee did not receive this contribution please note this fact in a letter to the Commission.
3. According to the last minute contribution report filed on October 30, 2008 and October 31, 2008, the committee received a \$1,500.00 contribution on 10/27/2008 from KCP & L Power PAC and a \$750.00 contribution on 10/30/2008 from 3M. These contributions were not reported by your committee on Schedule A (Contributions and Other Receipts) of the January 10, 2009 Receipts and Expenditures Report. These contributions must be reported on both the last minute report and the January 10, 2009 report. An amended Schedule A must be filed showing both of these contributions. This error will also cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must be filed.
4. According to the last minute contribution report filed on October 30, 2008, the committee made a \$5,189.84 expenditure on 10/24/2008 to Econ-O-Print. This expenditure was not reported by your committee on Schedule C (Expenditures and Other Disbursements) of the October 27, 2008 Receipts and Expenditures Report. This expenditure must be reported on both the last minute report and the January 10, 2009 report. An amended Schedule C must be filed showing this expenditure. This error will also cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must be filed.
