1. K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: . . . for other state officers elected from the state as a whole, . . . \$2000 for each primary election . . . and an equal amount for each general election." The Praeger campaign reported receiving the following contributions:

All of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted contributions in excess of the legal limit amounting to \$2350. We would suggest that these contributions be refunded immediately. The return of these contributions should be noted on Schedule C (Expenditures and Other Disbursements) of the October 25, 2010 Receipts and Expenditures Report.

2. K.S.A. 25-4148 (b) (7) requires that when an expenditure is made by payment to an advertising agency, public relations firm or political consultants for disbursement to vendors, the report of such expenditure shall show in detail the name of each such vendor and the amount, date and purpose of the payment to each. Expenditures amounting to 103,785.00 were made to Mary Christine & Assoc. for Radio/TV buys. Please submit the required supplemental information as an amendment to Schedule C on the July 26, 2010 Receipts and Expenditures Report.
