Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.


We have completed the review of the October 25, 2010 and the January 10, 2011 Receipts & Expenditures Reports you filed on behalf of the Dennis McKinney for Secretary of State campaign.

During the review, we found a contribution of \$300 or more that was received from the Kansas State Firefighters PAC on October 27, 2010. This contribution should have been shown on the Last Minute Contribution Report and filed with the Secretary of State on October 28, 2010. You were mailed a memo explaining the requirement on October 12, 2010.

In the future, you must be certain that any last minute contributions of \$300 or more are reported on the appropriate date. The failure to do so may result in a civil fine being assessed by the Governmental Ethics Commission.
