1. According to the reports filed with the Secretary of State, the following PAC and party committee reports making contributions to the Jeanna Repass campaign:

These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2023 report. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

2. According to the Candidate Last Minute Contribution Report filed on 11-4-22 by the Jeanna Repass campaign, the campaign received the following contributions:

These contributions were not reported by your campaign on the January 10, 2023 report. These contributions must <u>also</u> be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2023 report.

- Schedule A (Contributions and Other Receipts) of the January 10, 2023 report lists contributions that were received on October 27, 2022 and disclosed on the amended October 31, 2022 report. These contributions were also reported twice on the January 10, 2023 report. An amended Schedule A for the January 10, 2023 report must be filed removing all duplicate entries that were reported on the amended October 31, 2022 report.
- 4. Schedule C (Expenditures and Other Disbursements) of the January 10, 2023 report lists expenditures that are reported in triplicate. An amended Schedule C must be filed removing the excess expenditures that were reported.
- 5. Schedule C (Expenditures and Other Disbursements) of the January 10, 2023 report lists expenditures with the purpose of expenditure reported as "Meeting/Travel". Pursuant to Advisory Opinion 2007-14, the candidate can only be reimbursed for mileage at the state mileage reimbursement rate, not for fuel. The Commission opined "due to the difficulty in determining the allocation of vehicle expenses between a candidate's personal use of a vehicle and the candidate's use of a vehicle for holding political office or for campaign purposes, the Commission now determines that beginning January 1, 2008, the use of campaign funds to pay for otherwise un-reimbursed vehicle expenses will be limited to the state mileage

reimbursement rate." When claiming reimbursement for mileage from campaign funds, the treasurer needs to keep detailed records for mileage expenditures showing the dates of travel, the necessity for and specific purpose of the travel, and the actual mileage traveled. If any of the "Meeting/Travel" expenditures were for fuel, it will be necessary for the candidate to reimburse the campaign account for the fuel purchased. This reimbursement will need to be disclosed on Schedule A (Contributions and Other Receipts) of the January 10, 2024 Receipts and Expenditures Report.

6. Schedule D (Other Transactions) of the July 25, 2022 Receipts and Expenditures Report lists a loan payable totaling \$500 to Jeanna Repass. The \$500 loan payable is not carried forward as a loan payable to the October 31, 2022 report or the January 10, 2023 report, nor is it on Schedule C (Expenditures and Other Disbursements) as repaid. All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended January 10, 2023 report must be filed disclosing the disposition of this debt.
