
Dear Ms. Williams:

This letter and the following pages are submitted in response to your letter of August 21, 2007. The letter pointed out my campaign's oversight in not reporting the specific purpose of the expenditure to ASA Marketing in the October 26, 2006, Campaign Finance Report. I assure you this was a mistake and was not done purposefully.

Following this letter is the supplemental information requested to amend Schedule C. This details what amounts were paid to which radio stations for radio advertisements. It includes a portion of the fee for media production as well. Also included with this letter is a copy of the invoice from ASA Marketing detailing the amounts paid to each radio station and the media production cost. Please note that \$147 of the invoice from ASA Marketing was paid after the October 26, 2006, filing deadline. That \$147 was included as a media production expense on the January 10, 2007, Campaign Finance Report.
