Dear Carol,

I write in response to the two "Notifications of Material Error or Omission In A Receipts and Expenditures Report" I received from your office last month. Per your instructions, I have now filed an amended "Receipts and Expenditures Report for October 30, 2006" and an amended "Receipts and Expenditures Report for January 10, 2007" with the Secretary of State and the Sedgwick County Election Office.

For your information, I have detailed below specific responses to the errors or omissions you noted in your letters.

Receipts and Expenditures Report Due October 30, 2006

(1) You noted that my reports included two contributions from the Kansas National Education Assn. PAC ("KNEA") that exceeded the legal limit (\$500) for the primary election.

Response: My campaign received only one contribution from KNEA on June 27, 2006 during the primary election. My report contained a duplicate entry for KNEA due to a typographical error, which is corrected in the amended report.

(2) You noted that my reports included three contributions from Dasa Gangadhar that exceeded the legal limit (\$500) for the general election.

Response: My report omitted the name of Dasa Gangadhar's spouse, Nalini Gangadhar, who made the contributions along with her husband. A couple is entitled to donate \$1000 per election cycle and therefore the three contributions from the Gangadhars (totaling \$550) are within the legal limit. This is corrected in the amended report.

(3) You noted that I should remove a \$500 in-kind contribution from Raj Goyle on Schedule B because it is not required to be listed.

Response: I have removed the entry in the amended report.

(4) You noted that I should provide supplemental information regarding a payment of \$18,320.60 to Media Partners on October 26, 2006 in order to comply with K.S.A. 25-4148(b)(7).

Response: In a phone conversation with your office I was informed that the requirement is satisfied by providing an invoice from Media Partners. I have included the invoice from Media Partners in the amended report.

Receipts and Expenditures Report Due January 10, 2007

(1) You noted that I should provide supplemental information regarding a payment of \$315 to Media Partners on November 3, 2006 and of \$1,175 to Dixon Davis on November 6, 2006 in order to comply with K.S.A. 25-4148(b)(7).

Response: In a phone conversation with your office I was informed that: a) with respect to the payment to Media Partners, the requirement is satisfied by providing an invoice from Media Partners, which I have included in the amended report; b) with respect to the payment to Dixon Davis, I was informed that it did not fall under K.S.A. 25-4148(b)(7) because the payment was for creative services. I also note here that due to a typographical error, the incorrect amount was listed for the payment to Dixon Davis. The correct amount is \$1,775 (not \$1,175), which is corrected in the amended report.
