Per your letter of 8/21/07, I was advised that the Campaign Fund for Brenda K Landwehr had two contributions in excess of the legal limit in 2006.

The explanation for this is as follows:

Our October 30, 2006 report details that we received two checks from the Kansas Association of Homes & Services for the Aging—one for \$250.00 and one for \$300.00. It was determined that the check for \$250.00 was actually made payable to the House Republican Campaign Committee, but mailed to Brenda K. Landwehr. Our check for \$250.00 was immediately sent to the House Republican Campaign (RHCC)) to correct this issue. I have enclosed a copy of each check.
