Enclosed please find my amended October 30, 2006 report and my amended January 10, 2007 report. I have corrected the errors and omission in question.

Regarding the originally listed August 2, 2006 receipt date for the KTLA Consumer/Civil Justice PAC, I discovered that date was an error on our part. I actually received the check on July 25, 2006 – well before the general election cycle. Attached please find a copy of the letter from KTLA sending me the donation along with a copy of the check. As you can see, the check is dated 7-21-06.

On August 2<sup>nd</sup>, I also deposited that check and a check from Alan L. Rupe and his wife. Unfortunately, on the report we accidentally listed the date of deposit instead of the date of check receipt on these two donations.

I have corrected the report to reflect a July 24, 2006 date as the date I received the KTLA donation, so this should render the need for a refund to KTLA unnecessary. I am 100% certain I received that check well before the August 1 primary date. However, apparently we let the check sit and didn't get it deposited until August 2<sup>nd</sup>.

As stated, On August 2<sup>nd</sup>, I also deposited a check from Alan L. Rupe and Rhonda K. Wills (husband and wife). I neglected to put Rhonda Wills' name on the report, but listed the donation as Alan L. Rupe on August 2, 2006 (see attached deposit slip). In my amended

report, I added Rhonda Wills to the report and amended the date of receipt.

Also, I appreciate your pointing out the error regarding the Kansas City Chamber of Commerce (BizPac). We had neglected to list that donation in the report, but I have corrected that. I have also corrected all the other errors that you pointed out in my reports.

On my reports, we list our checks on the date of receipt, but for some reason the August 2<sup>nd</sup> deposit checks were listed on date of deposit, which was a mistake.
