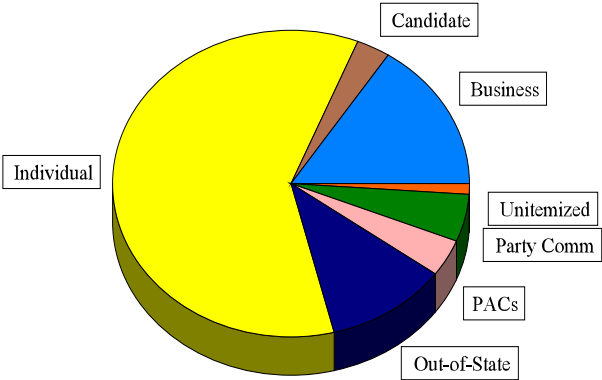

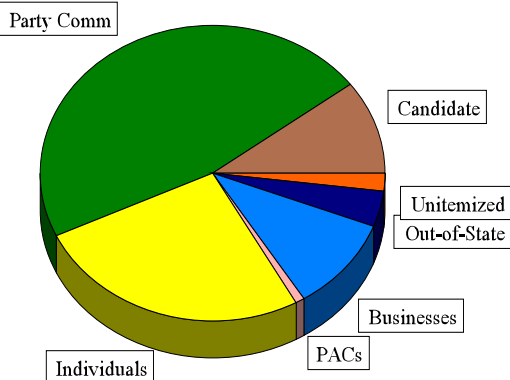

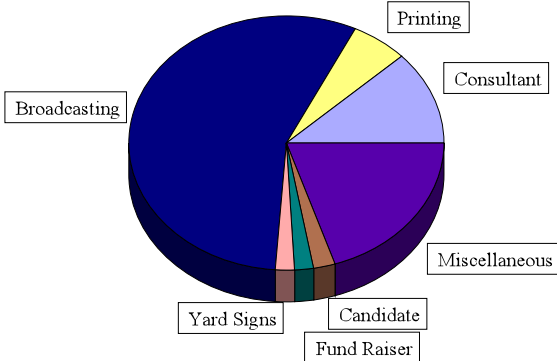

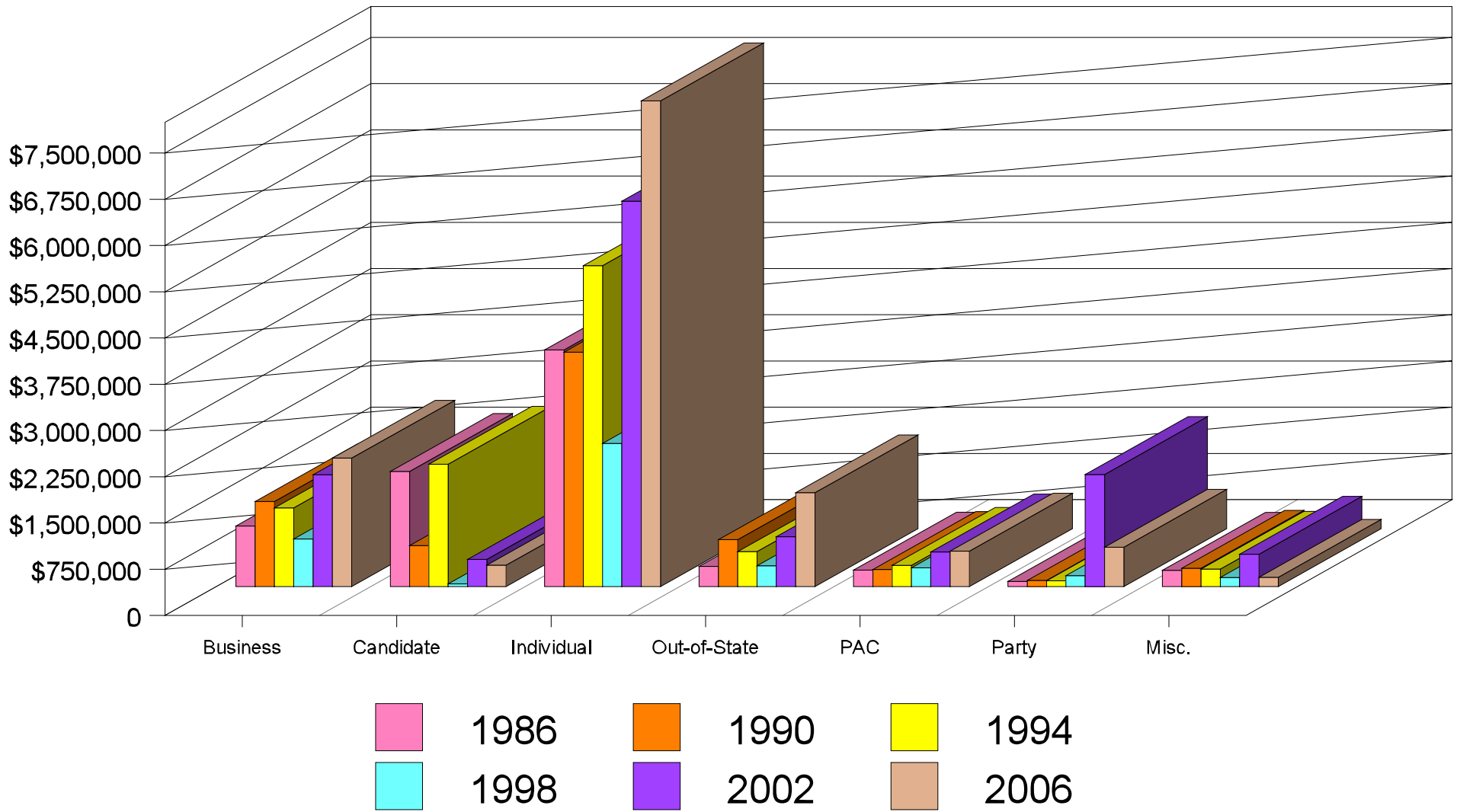

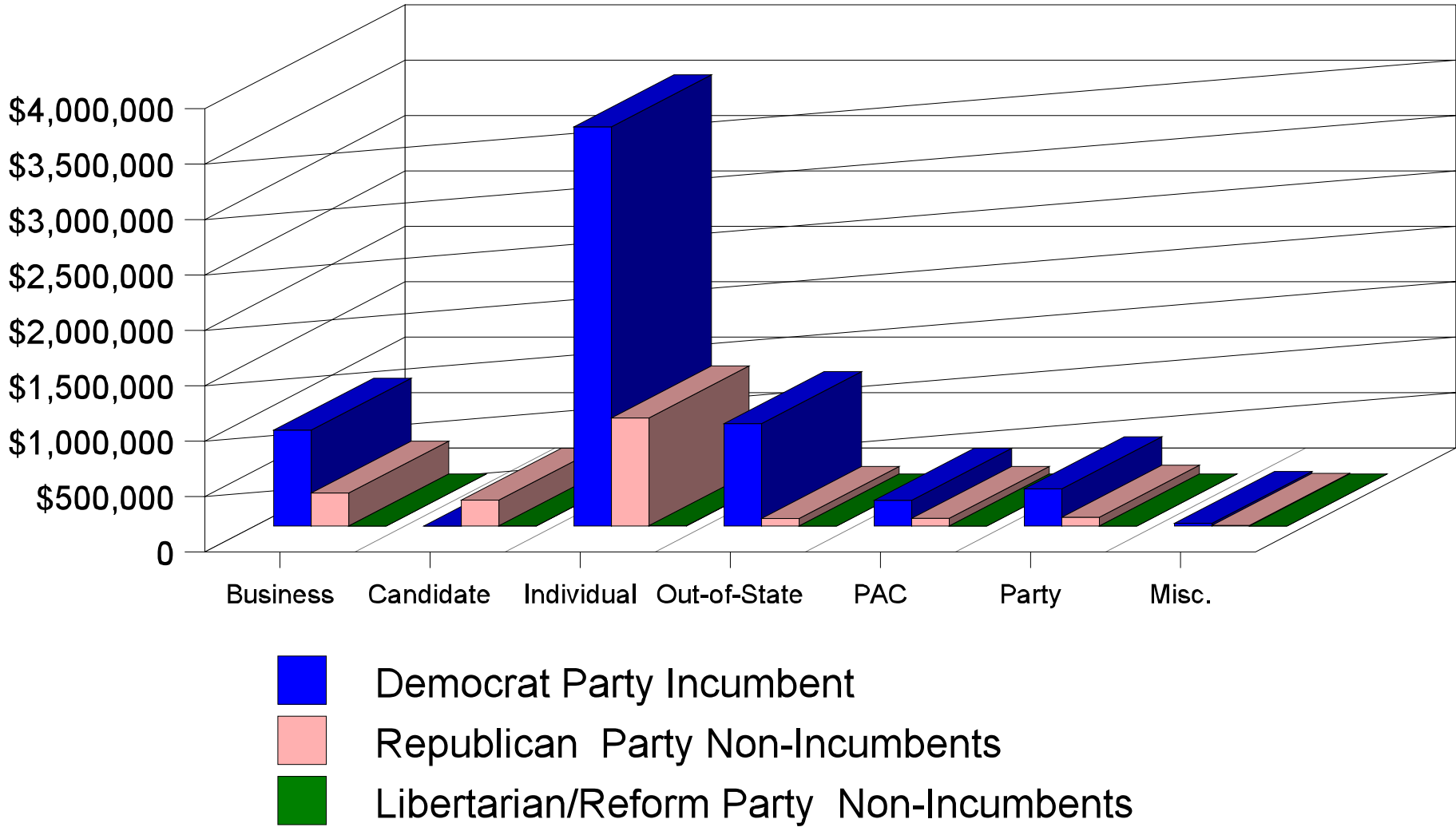

## Gubernatorial Monetary Contributions Demo/Repub--Incumbent/Non-Incumbent

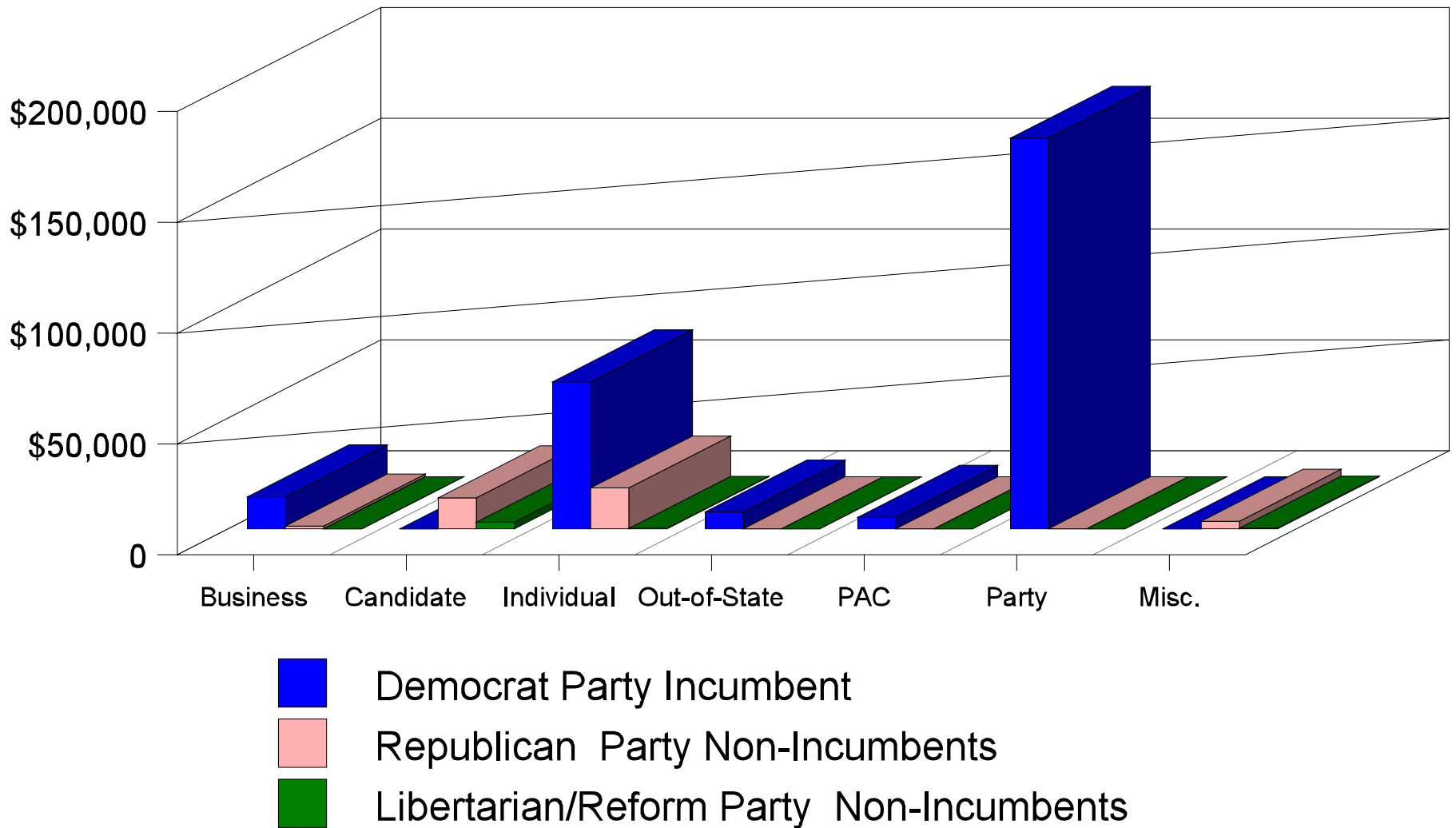

## Gubernatorial In-kind Contributions Demo/Repub--Incumbent/Non-Incumbent

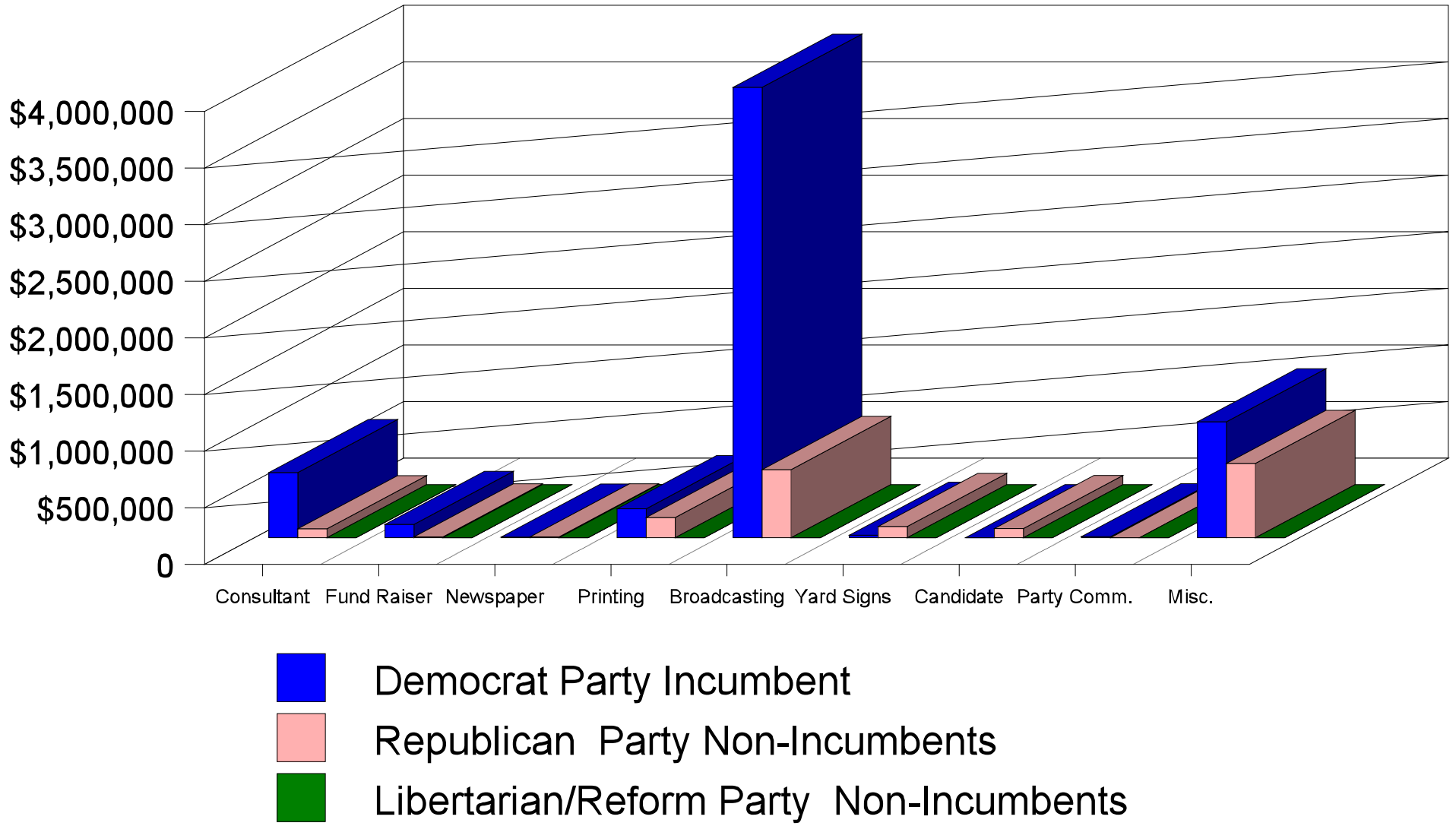

## Gubernatorial Expenditures Demo/Repub--Incumbent/Non-Incumbent



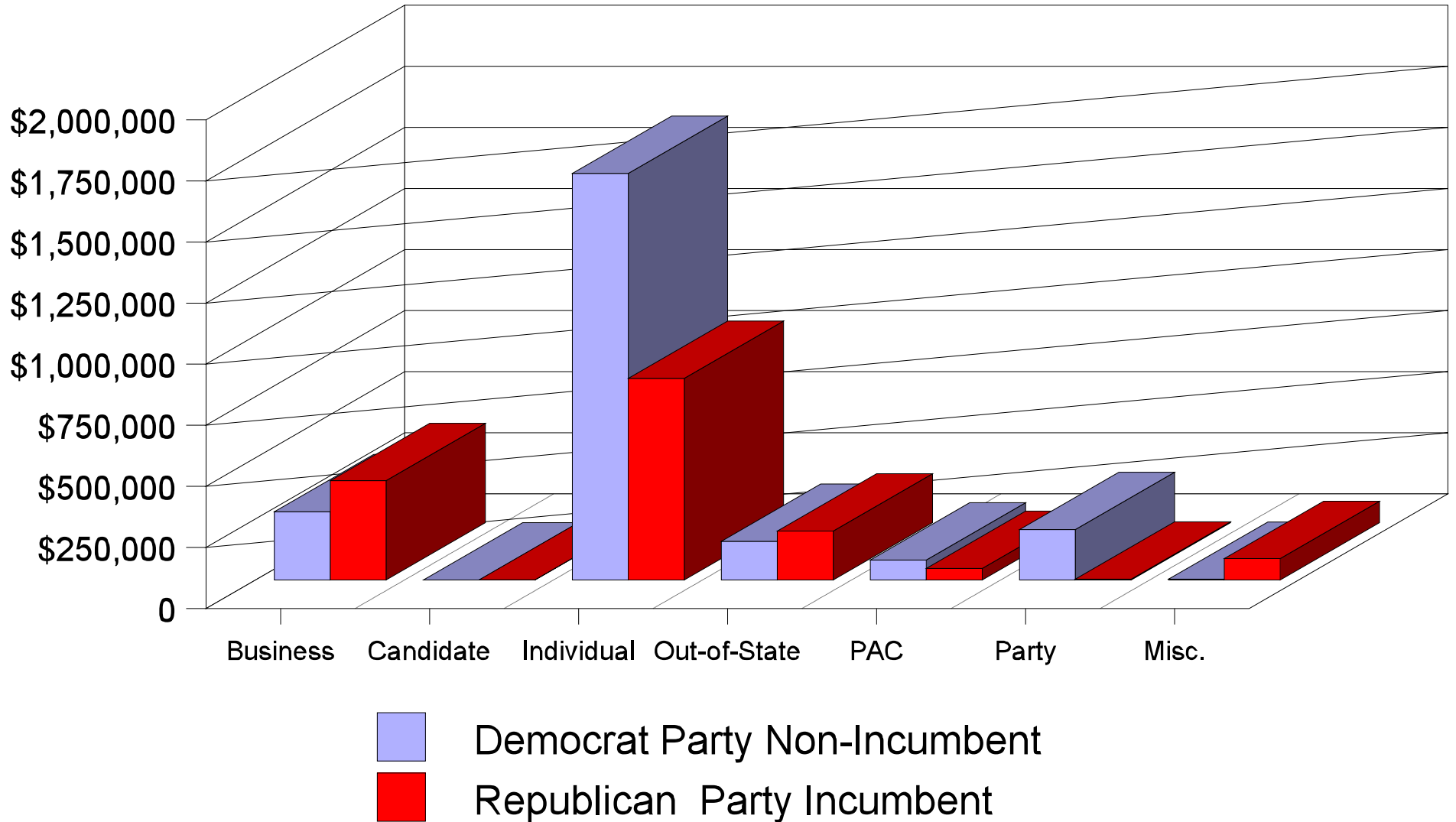

## Attorney General Monetary Contributions Demo/Repub--Incumbent/Non-Incumbent

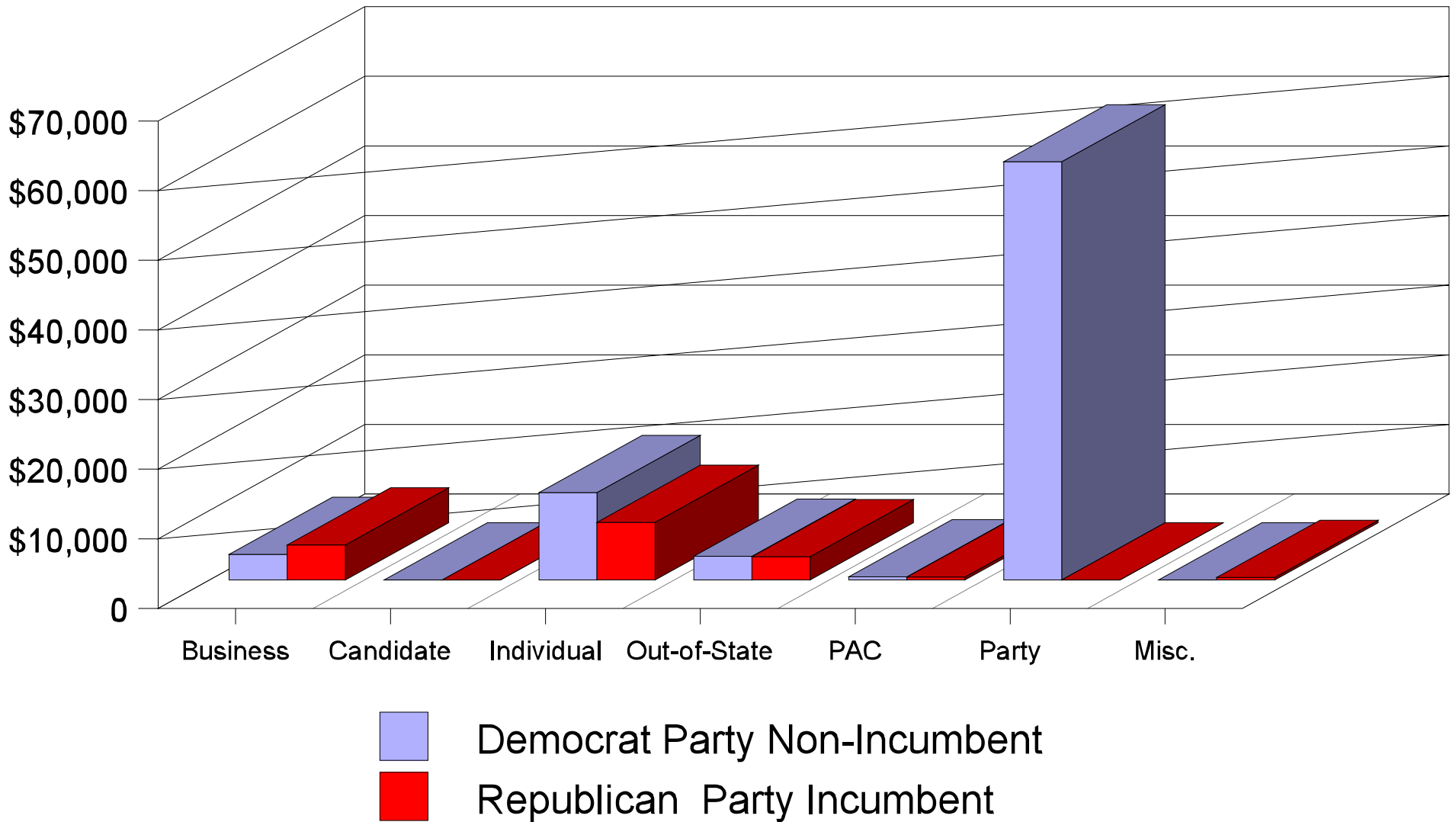

## Attorney General In-Kind Contributions Demo/Repub--Incumbent/Non-Incumbent

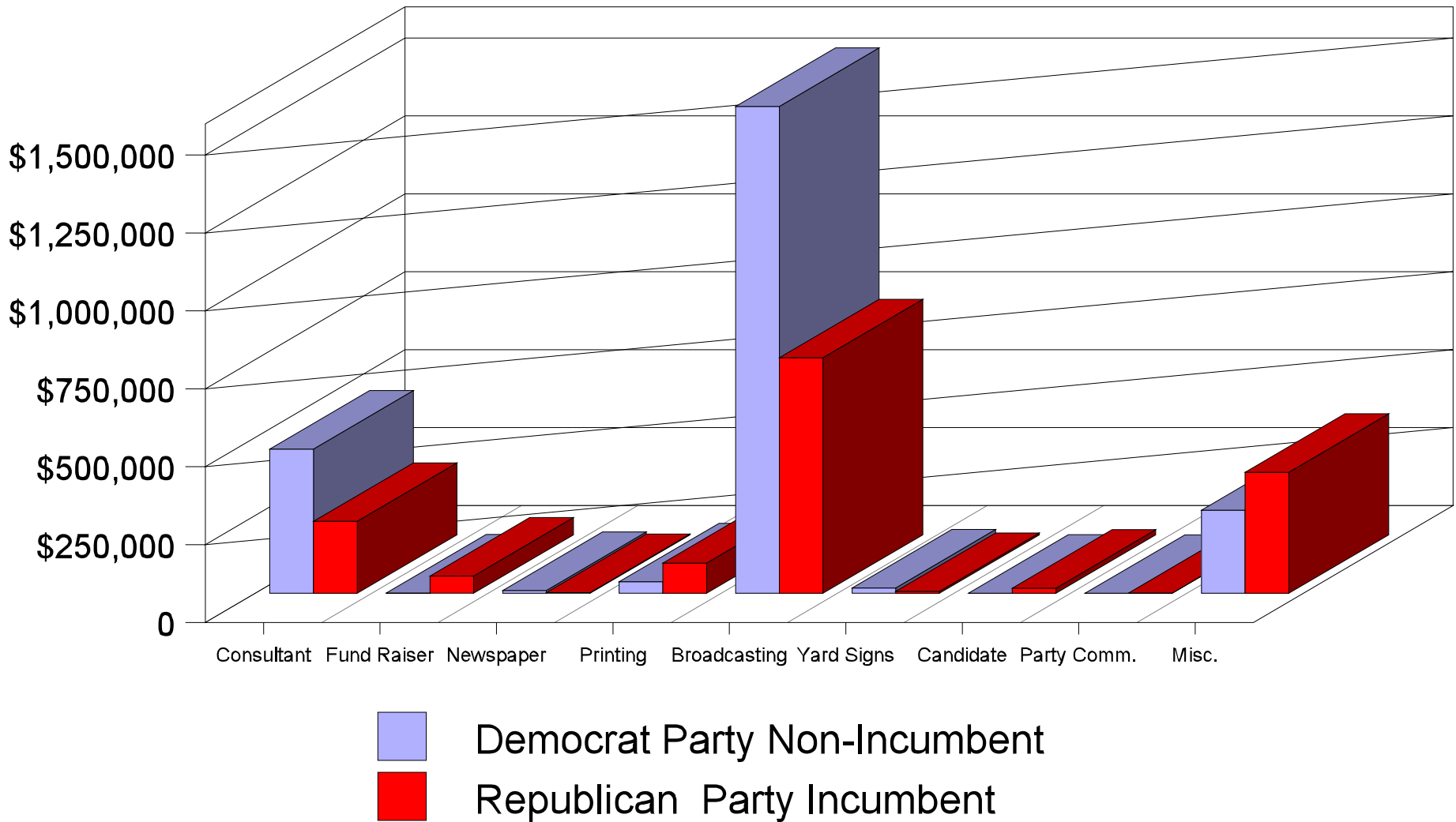

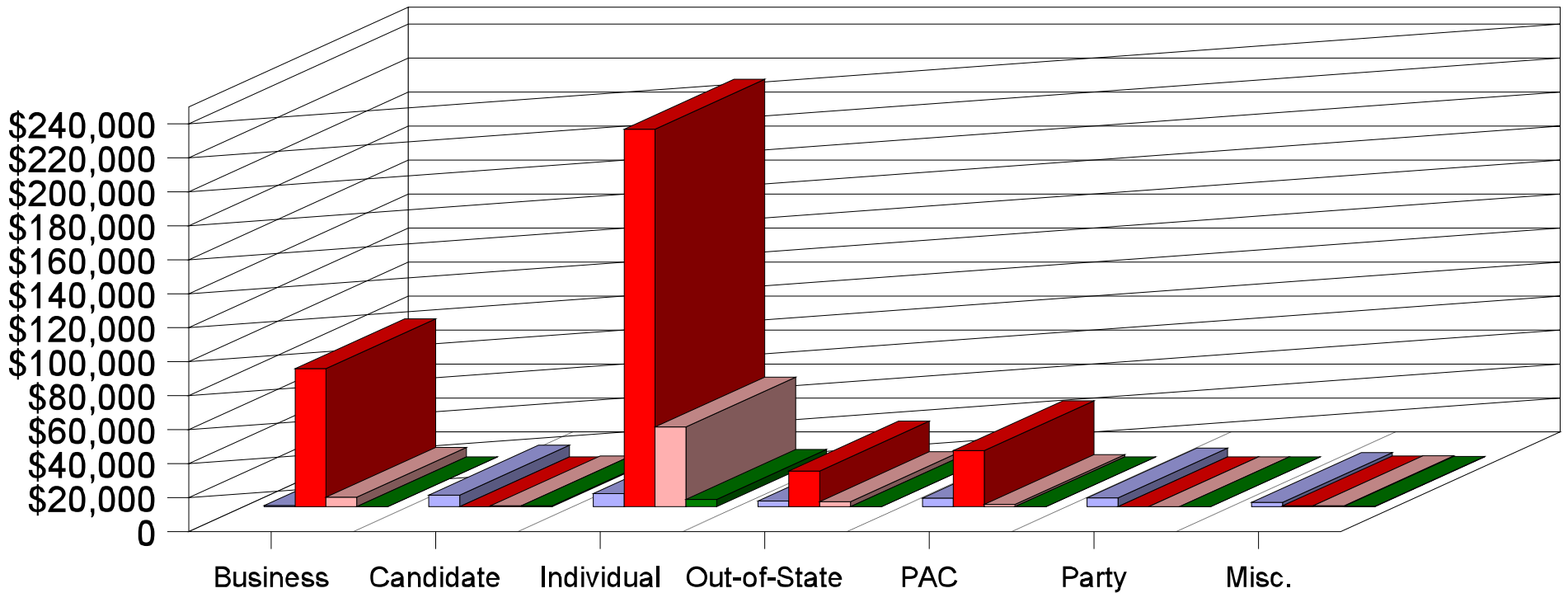

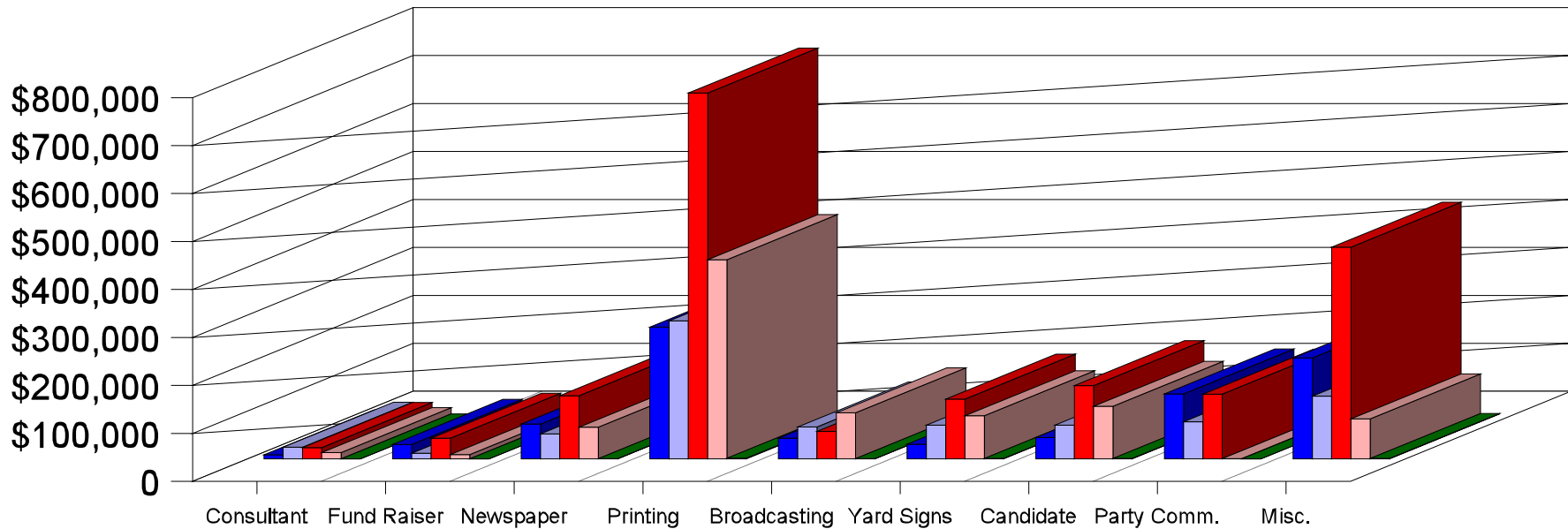

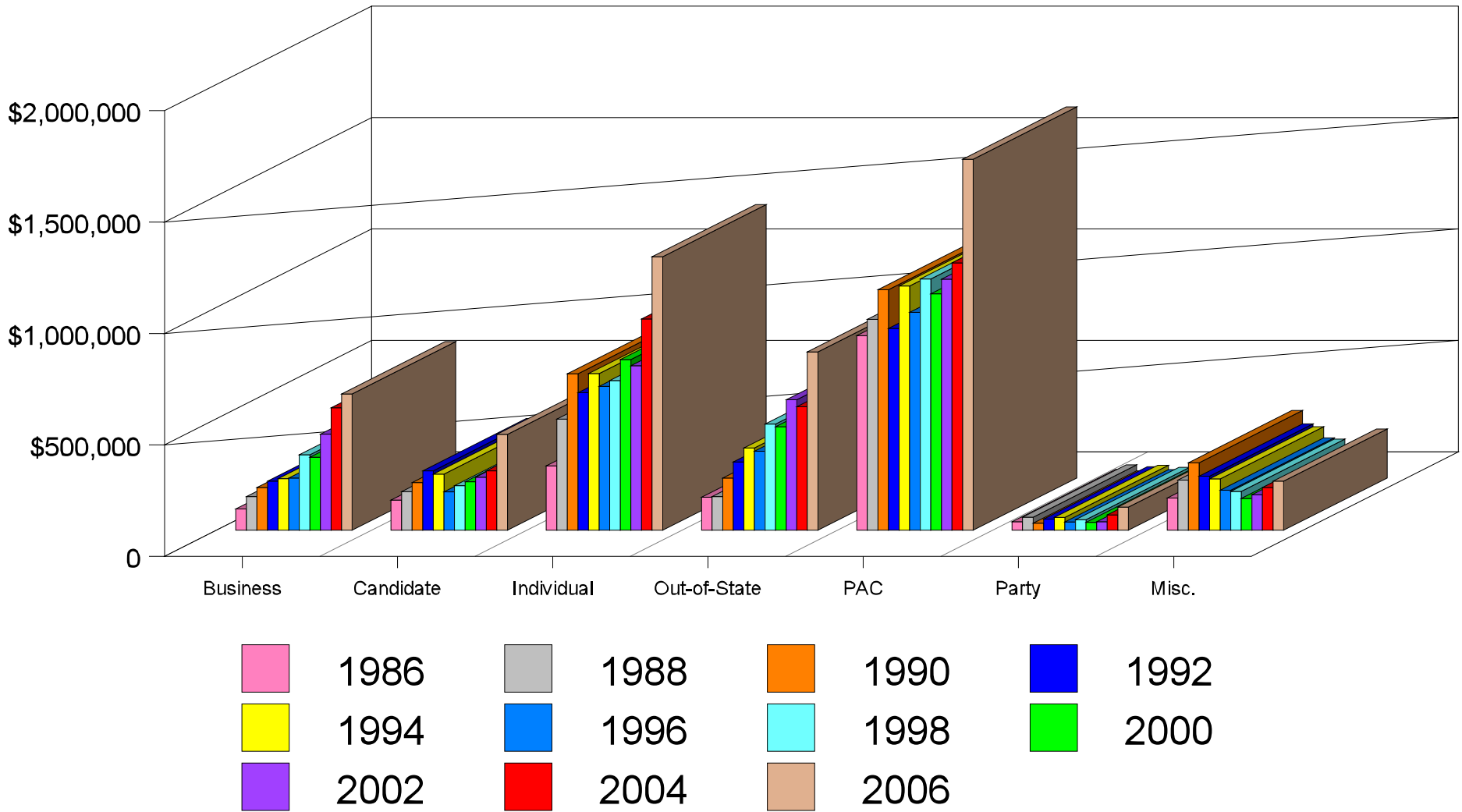

## EXPLANATION OF STATISTICAL DATA

To obtain statistical data, Governmental Ethics Commission staff code the receipts and expenditures disclosed on a candidate's "Receipts and Expenditures Report". Coding consists of the following categories:

### **Receipts:**

- 1) Individual (from Kansas or out of state)
- 2) Business (includes corporations, partnerships, and associations)
- 3) PAC (Political Action Committee registered with the GEC)
- 4) Out-of-State (out of state businesses, unions, PACs)
- 5) Candidate (candidate and/or candidate spouse)
- 6) Party (party committee in Kansas or national party committee)
- 7) Unitemized or miscellaneous (includes contribution under \$50, rebates, refunds)

### **Expenditures:**

- 1) Newspaper (examples: newspaper ads, ads in programs)
- 2) Broadcasting (examples: radio & TV ads)
- 3) Printing (examples: printing of handouts, postage, distribution)
- 4) Yard Signs (examples: yard signs, bumper stickers, billboards, pencils, etc.)
- 5) Consultant (examples: all fees associated with hiring a consultant, including travel)
- 6) Candidate (examples: mileage, loan reimbursements, food)
- 7) Fund Raiser (examples: fund raiser expenses including invitations, food, beverages, etc.)
- 8) Party Committee (examples: contributions to party committees)
- 9) Miscellaneous (examples: computers, fax machines, cell phones, subscriptions, staff salaries)
