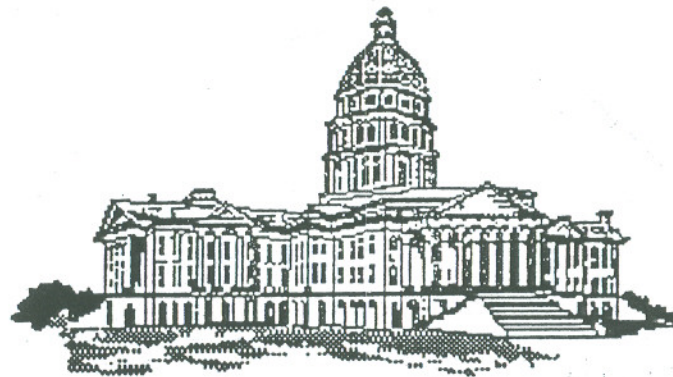

PREFACE

This campaign statistics report has been prepared with the objective of increasing the utilization of reported campaign finance information and is intended to:

- (1) Meaningfully condense reported campaign finance information into a published form which is more accessible to the citizens of Kansas;
- (2) Present the candidates' receipts in a manner which allows the reader to assess financial influences on the election process, and allows comparison in financing between candidates;
- (3) Establish a basis for identifying trends in campaign financing by comparing information from year to year.

The information contained in this report is only as valid and as complete as its source--the campaign finance reports filed by the candidates. Handwritten receipts and expenditures reports are at times difficult to read, therefore an error could have been made in deciphering a name or a dollar amount. Obvious reporting errors have been corrected in compiling statistics for this report. However, many errors and omissions are undetectable and are unavoidably reflected in the report. Time and resources did not permit thorough cross-checks with reports filed by all contributing entities.
